Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies.

Non-affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.
	Elevate may share personal information with non-affiliated third parties, such as broker dealers, banks and investment advisers for business purposes. Elevate may also share personal information with parties who provide technical support, legal counsel, and accounting and compliance professionals.
Joint marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you.
